ed to furnish to the Georgia Poultry Lab-
oratory, P.O. Box 148, Oakwood,
Georgia, 30566, either an invoice, bill of
lading, or letter on each shipment which
gives the following information:

1. Name and address of shipper.
2. Name and address of consignee.
3. Approximate date of shipment.
4. Method of shipment.
5. Number and types of birds in each
shipment.
