## Captive Hatching of the Bahama Parrot

On May 4, 1994 the first of three Bahama Parrot chicks Amazona leucocephala bahamensis hatched from a clutch of four eggs at Ardastra Gardens and Zoo in Nassau, Bahamas. Two other eggs hatched on May 7 and 10. The fourth egg proved to be infertile.

The chicks were pulled for handrearing at 4, 1 and 4 days old respectively. This precaution was taken since the previous year three chicks had hatched successfully but then all died mysteriously after nearly a month with the parents.

Currently, the chicks are fully weaned and fledged and are doing just fine. Their first years will be spent educating the island population of the plight of their own endangered parrot species. As they reach maturity though, plans are in the works to pair them up with wild-caught stock from their native island of Great Inagua.

This is the first time in the world that Bahama Parrots have ever been successfully handraised. Also, to our knowledge, this is the world's only captive breeding pair of Bahama Parrots.



## World Bird Sanctuary & L'Avian Pet Products Provide Co-op Program

This is a cooperative effort to provide a productive life for captive birds that are endangered or for birds that have been mistreated, abandoned or need medical assistance. The program involves placing many of these birds with breeding projects, zoological institutions or in private homes if they require monitoring or

According to Walter C. Crawford, Jr., a major consideration with captive birds is providing a proper, nutritious and clean diet. It is the mission of WBS to take these birds and make sure that they are properly cared for and placed in suitable environments.

At present, one can find numerous species of birds at WBS and the species vary from month to month. WBS is a non profit, tax exempt organization which receives its funding from corporations, small companies, private individuals and some foundations. The food provided by L'Avian Pet Products not

only provides premium diets that ensure optimal nutrition for the birds but also help defray the costs of maintaining the many patients and residents at the sanctuary.

General Information: Now 10 years old, the Greater Brandon Avian Society is an informal group of people brought together through mutual interest in birds. ## Man Pleads Guilty to Smuggling Eggs

A Las Vegas man pleaded guilty Monday to a federal conspiracy charge for his involvement in a ring that smuggled Australian cockatoo eggs into the United States over a 10-year period.

John Barth, 46, incubated and hand-reared the cockatoo chicks to the point where they could be sold through a business in New York known as "Planned Parrothood."

Barth admitted that the value of the birds smuggled while he was part of the ring was up to \$800,000.

Five others accused of participating in the ring have pleaded not guilty to the charges and are awaiting trial. They are William Wegner of San Diego; Theodora Swanson of Memphis, Tennessee; and Brian Bradley, Mark Skillman and David Freda, all of New Paltz, New York.

The charges, contained in a federal grand jury indictment, also accuse Wegner, Bradley, Swanson and Skillman of smuggling in 137 cockatoo eggs in September 1990, and Wegner, Bradley, Swanson and Freda with attempting to import 71 cockatoo eggs a year later.

The indictment also charges Wegner with money laundering and filing false tax returns for 1987 through 1990, when he lived in Woodland Hills and Malibu. ●
